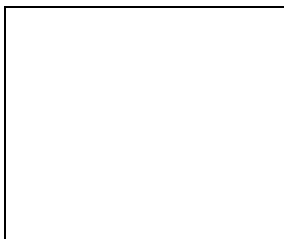

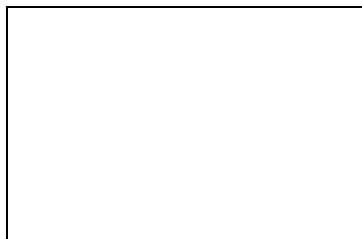

- (ii) If the filming involves activities mentioned in item (8)(A) or (8)(B) above, the notification form should be submitted at least 10 working days in advance of the filming date.
- (iii) The applicant should seek endorsement of the licensees/ authorized operators of the rafts concerned prior to the filming.
